## **Eligibility Qualifications**

- Have a Clear Anglican Ethos, Connection, Identity & Authority
- Headquartered in the United States or Canada
- Have a Religious, 501c3 or Equivalent Designation
- Be Involved in Cross-Cultural Mission

## **Affirmation Stipulations**

- AGMP Foundational Documents: Partner Covenant & Partnership Principles
- Statement of Faith: The Jerusalem Declaration or A Place to Stand
- Financial Accountability: Member of Evangelical Council of Financial Accountability or Alternative Accountability Structure

## **Active Participation**

- Attend 2 Face-to-Face Meetings per Year
  - o Annual Spring Business Meeting
  - o 2<sup>nd</sup> Annual Meeting as Identified by the AGMP Steering Committee
- Serve on an AGMP Collaborative Task Group
- Place AGMP Digital Button Prominently on Partner Web Site
- Collaborate in Preparing & Training Churches on Mission, Domestic & Global
- Pray & Support AGMP and its Partners

## **Application Process**

- Complete AGMP Partner Application
  - Designate Representatives
    - Primary: CEO, Chair, Rector or Corresponding Person
    - Secondary: Participates with Primary Representative
    - o Provide Organizational Overview
    - o Identify Two (2) AGMP References
- Obtain Required Signatures
  - Primary Representative
  - Each Member of Board or Policy-Making Body
- Complete Renewal Application Every Three (3) Years
